WHEREAS, bicycle and pedestrian mobility and safety are important issues to the Capital Area Metropolitan Planning Organization and supported in the MPO's Long-Range Transportation Plan; and,

WHEREAS, the MPO recognizes and applauds the Capital Area Bicycle and Pedestrian Stakeholders Group (BPSG) for their efforts toward enhancing the use of bicycle and pedestrian mobility options; and,

WHEREAS, the BPSG has identified the need to educate all individuals of the laws pertaining to bicyclists and motorized vehicles; and,

WHEREAS, activities in neighboring communities have led to the development of educational materials to be distributed in an effort to inform Triangle area citizens of these laws; and,

WHEREAS, the MPO believes that a coordinated statewide education effort is needed that would involve local transportation planning agencies, the Division of Motor Vehicles and relevant law enforcement agencies, which can best be served by administration through the North Carolina Department of Transportation, Division of Bicycle and Pedestrian Transportation;

NOW, THEREFORE, BE IT RESOLVED that the N.C. Capital Area MPO hereby expresses its support for the development of a bicycle education program which involves local transportation planning agencies, the Division of Motor Vehicles and relevant law enforcement agencies, administered through the North Carolina Department of Transportation, Division of Bicycle and Pedestrian Safety.
